Rebates	
Mental Health Care Plan To obtain a Mental Health Care Plan you will need to visit your GP or medical specialist (paediatrician or psychiatrist). A Mental Health Care Plan allows you to claim a rebate via the Medicare Benefits Schedule (MBS) for up to 10 individual therapy sessions and up to 10 group therapy sessions per calendar year. A review from your GP or medical specialist is required after 6 sessions, this will then allow access for up to 4 additional sessions. For more information please visit this site: www.psychology.org.au/medicare/fact_sheet/ MBS rebates are \$129.55 for consultation in clinic (Item number 80010) and via telehealth (Item number 80011). MBS rebates are \$32.90 for group therapy in clinic (Item number 80020) and via telehealth (Item number 80021). MBS rebates for home or school consultation are \$151.60 (Item number 80015).	
Private Health Insurance Please contact your provider for information as to whether your policy covers for psychological therapy and the rebates (and rules) that may apply.	
NDIS Our psychologists are not registered providers with the NDIS, however can accept NDIS clients under self-managed plans.
